

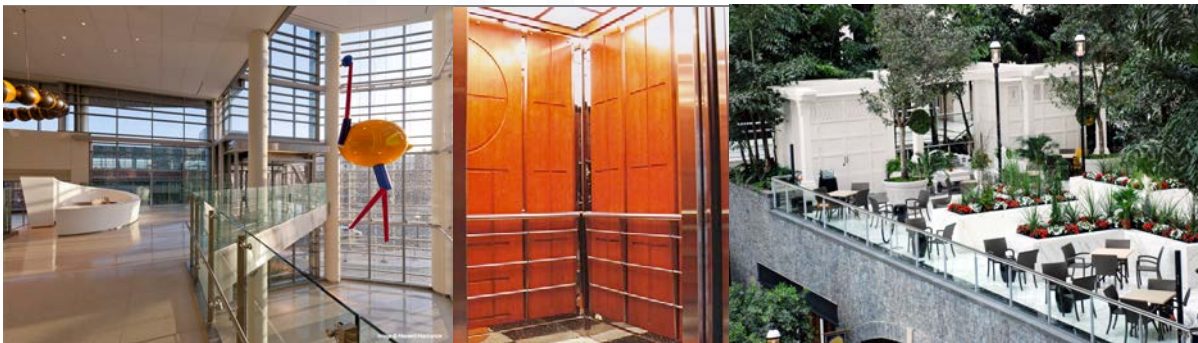


## SPECIALTY CONSTRUCTION SERVICES & PRODUCTS
